What is this product?

The Upright Umbrella - Global Leaders Fund is a contractual fund of the "securities fund" type under Swiss law.

The investment objective of the sub-fund is primarily to provide investors with long-term capital growth by investing in a portfolio of selected global equities and other equity securities and rights of companies in developed countries that are market leaders in their industries, have good earnings potential, strong fundamentals and transparent business operations.

The sub-fund is suitable for investors with a (medium to) long-term investment horizon (5 years and more) who primarily seek growth of the capital invested and can accept relatively strong fluctuations and a longer-lasting decline in the net asset value of the fund units. They are familiar with the main risks of an equity investment.
